 - To receive Tribal/Indian Preference consideration, proof of tribal enrollment is required.
 - An enrolled member of a federally recognized tribe must provide a copy of his/her tribal enrollment card.
 - A direct descendent of the Spokane Tribe must provide a certification from the Tribal Enrollment Office.
 - A person seeking consideration as a spouse of a Spokane Tribal Member must provide proof of marriage or confirmation of domestic relationship.
 - Employment Eligibility Verification Form I-9 is a federal requirement and appropriate ID must be shown when hired.
 - Proof of education is required for positions that require a college degree.
